



# VortexFX Tokenomics Overview

## 1. Executive Summary

VortexFX (VFX) is a decentralized finance (DeFi) platform designed to deliver innovative financial solutions through a robust tokenomics framework. With a fixed total supply of 100,000,000 VFX tokens and no further minting, VFX ensures scarcity and supports long-term value growth. The platform targets a \$5,000,000 capital raise, prioritizing community participation with a 55% public allocation. Investors benefit from staking yields up to 67.7% APY and projected returns ranging from 20–24x for seed investors to 2.8–3.4x for final-round participants, based on a launch price target of \$1.00–\$1.20.

## 2. Token Distribution

The VFX token allocation is designed to balance ecosystem growth, participant incentives, and market stability.

The ICO is structured across multiple stages to ensure equitable access and progressive pricing, optimizing fundraising and participation.

## 4. Vesting Schedule

**Seed & Private Rounds:** 50% unlocked at Token Generation Event (TGE), remainder vested after 30 days.

**Public Sale:** 100% unlocked at TGE for immediate liquidity.

**Team & Advisors:** 24-month lock to ensure sustained commitment.

**Strategic Partners:** 25% unlocked at TGE, with the balance released over 9 months.

## 5. Staking Program

VFX offers a tiered staking program to incentivize token retention and ecosystem participation, with attractive yields and volume-based bonuses.

**30 Days:** 15% APY (flexible withdrawal).

**90 Days:** 30% APY (fixed term).

**180 Days:** 45% APY (fixed term).

**365 Days:** 67.7% APY (fixed term).

**Volume Bonuses:**

- ☐ +2% APY for 10,000 VFX.
- ☐ +5% APY for 50,000 VFX.
- ☐ +10% APY for 100,000 VFX.
- ☐ +15% APY for 500,000 VFX.



## 6. Use of Funds

Proceeds from the ICO will be allocated strategically to ensure sustainable growth and operational excellence.
